PUBLIC COMMENTS

There were no public comments.

MINUTES OF PREVIOUS MEETING(S)

The Board considered approving the minutes of the February 8, 2023, regular meeting. After review and discussion, Director Combs moved to approve the minutes as submitted. Director Traweek seconded the motion, which passed unanimously.

FINANCIAL AND BOOKKEEPING MATTERS

Mr. Burton reviewed the bookkeeper's report, including the list of checks for payment of District bills, a copy of which is attached. After review and discussion, Director Mitchell moved to approve the bookkeeper's report and payment of the bills. Director Quiroga seconded the motion, which carried unanimously.

CONVENE IN EXECUTIVE SESSION PURSUANT TO SECTION 551.071, GOVERNMENT CODE, TO CONSULT WITH ATTORNEYS, AND PURSUANT TO SECTION 551.074, TEXAS GOVERNMENT CODE, TO DELIBERATE THE APPOINTMENT, EMPLOYMENT, EVALUATION, OR DUTIES OF AN EMPLOYEE

At 10:20 a.m., Director Bechtel announced that the Board was convening in executive session pursuant to Sections 551.071 and 551.074, Texas Government Code.

RECONVENE IN OPEN SESSION AND AUTHORIZE APPROPRIATE ACTION

At 11:05 a.m., Director Bechtel announced that the Board was reconvening in open session. Upon reconvening in open session, no action was taken.

<u>GULF COAST PROTECTION DISTRICT COMMITMENT TO CONSIDER NAVIGATION</u> <u>IMPACTS OF CERTAIN DESIGNS</u>

Director Bechtel discussed the Board's receipt and acknowledgement at last month's meeting of the Ship Simulation Transit Scenario Modeling and Ship Pilot Study of the Maritime Implications for Commercial Ship Transits of the Proposed Houston Ship Channel Gate Complex (the "Study"). He discussed the District's commitment, as the non-federal sponsor, to represent all stakeholder interests. Director Traweek added that all stakeholder input is critical and important to the success of the projects.

REPORT FROM U.S. ARMY CORPS OF ENGINEERS

Maj. O'Sullivan updated the Board on efforts related to the Coastal Texas Protection and Restoration Feasibility Study. He said USACE is working on the memorandum of understanding with

the District and the GLO, in addition to funding package submittals. He responded to questions regarding the timing of the memorandums of understanding and the preference for separate memorandums of understanding with the District and the GLO.

Maj. O'Sullivan next updated the Board on efforts related to the Sabine Pass to Galveston Bay Coastal Storm Risk Management Program ("S2G"). He reported on recent and upcoming meetings and engagements and acquisitions and contract awards.

REPORT FROM TEXAS GENERAL LAND OFFICE

There was no report from the General Land Office.

REPORT FROM BOARD PRESIDENT

Director Bechtel reported on recent hearings and meetings at the Texas Capitol with House and Senate Committees, legislators, and GLO representatives. He discussed filed legislation that would impact the District. Director Bechtel then discussed local meetings and events.

REPORT FROM EXECUTIVE DIRECTOR

Ms. Sunstrum reported on continued meetings and work on funding at the state and federal levels.

<u>REPORT FROM ORANGE COUNTY DRAINAGE DISTRICT AND JEFFERSON COUNTY</u> <u>DRAINAGE DISTRICT NO. 7</u>

Mr. Gordon reported on recent meetings of the District's program management team with stakeholders and USACE representatives. He discussed a senior leaders meeting and executive governance meeting with USACE, the stakeholder partnering forum and Industry Day hosted by USACE, and a workshop hosted with Orange County elected officials regarding the status of the interior drainage analysis efforts. He also discussed an upcoming interior drainage workshop with USACE to review the results of recent task orders and to determine the path forward on upcoming interior drainage work.

Mr. Gordon next discussed the non-federal sponsor's responsibility to conduct HTRW investigations. He discussed efforts to advance an initial set of Phase 2 environmental borings, which could be done in the near future under a categorical exclusion the USACE is pursuing. However, he clarified that the full HTRW investigation would require additional environmental clearances which the USACE is working on currently but may not receive until 2024. He stated that the District team is collaborating closely with the USACE to advance these efforts.

Mr. Gordon then discussed the program management team's preparation of a draft Project Management Plan for the Orange County Separable Element of S2G, outlining the roles and responsibilities of USACE and the District, important schedules and milestones, and the protocols for working together. He then responded to questions from the Board about the information included in the Plan.

UPDATE FROM REGION 6 STATE FLOOD PLANNING GROUP

Director Bakko reported on efforts by the Region 6 San Jacinto Regional Flood Planning Group to review Flood Management Evaluations to identify any that may be elevated to Flood Management Projects.

SCHEDULE AND LOCATION FOR NEXT MEETING

Director Bechtel reported that the District's next meeting will be on April 12th at 10:00 a.m. in Galveston.

ADJOURNMENT

There being no further business to come before the Board, the meeting was adjourned.
