Job Description:

The Gulf Coast Protection District (the District) has an immediate opening for an executive-level position to provide leadership and oversight of the District's activities related to the advancement of the Coastal Texas Project. This project is a \$30 billion plus investment to deliver protection from coastal storm surge for the communities, nationally important industries, and vital ecosystems of the Texas Gulf Coast. The selected applicant will serve as the District's Senior Project Manager for the Coastal Texas Project. In this capacity, they will be responsible for directing and overseeing a team of District employees and professional services contractors to advance the Coastal Texas Project and to fulfill all contractual requirements of the non-federal sponsor, as detailed in partnership agreements with the U.S. Army Corps of Engineers. The successful applicant should be based in the greater Houston area or be able to efficiently relocate to the greater Houston area. This position offers significant opportunity for growth. The Senior Project Manager will report directly to the Executive Director.

Responsibilities:

- In conjunction with the Executive Director, represent the District in collaborative efforts with the U.S. Army Corps of Engineers and Texas General Land Office related to the Coastal Texas Project.
- Manage the operation of employees and professional services contractors to ensure Coastal Texas Project efforts are progressing according to scope, schedule, and within budgetary guidelines.
- Work collaboratively with the District Executive Team to develop near-term and long-term strategic plans for efforts related to the Coastal Texas Project.
- Collaborate with the District's project management team in coordinating efforts and developing consistent project management practices and procedures between the Coastal Texas and Sabine to Galveston Projects.
- With Executive Director and Board of Directors, work with local governments, stakeholders, and academic institutions to develop and support local priorities.
- With District Executive Team, assist in the development of annual budgets and ensure that assigned programs operate within established budgets.
- Work with CFO and other team members to track and submit work in kind activities.

- Report on District activities to the Board of Directors.
- Serve as resource in engagements with elected officials at the local, state, and federal levels.
- Support outreach and engagement activities with local stakeholders and interested parties.
- Represent the Gulf Coast Protection District at conferences and events.
- Perform other duties that may be added or changed as the course and scope of the job directs.
